Compact Action

The Columbia River Compact agencies of Oregon and Washington met today and took the following actions:

Non-Indian Fisheries

Late Fall Commercial Salmon Fishery

- Adopted non-Indian commercial fishing periods as follows:

Season:	7 PM Tuesday October 13 to 7 AM Wednesday October 14, 2009	(12 hrs)
	7 PM Thursday October 15 to 7 AM Friday October 16, 2009	(12 hrs)
	7 PM Sunday October 18 to 7 AM Monday October 19, 2009	(12 hrs)

Area: Zones 4-5.

Gear: 8" minimum and 9¾ inch maximum mesh size restrictions in effect.

Season:	7 AM to 7 PM Wednesday October 14, 2009	(12 hrs)

Area: Zones 1-5

Gear: 9" minimum and 9¾ inch maximum mesh size restrictions in effect.

- The following Allowable Sales, Miscellaneous Regulations, Sanctuaries, and Washington Reporting Rule apply to all non-Indian commercial salmon seasons adopted above:

Allowable Sales: Salmon and white sturgeon. A maximum of **seven** white sturgeon may be possessed or sold by each participating vessel during each calendar week (Sunday through Saturday) of the open fishing periods. The **seven** white sturgeon possession and sales limit includes mainstem fisheries **only**. Select Areas remain closed to white sturgeon retention.

Miscellaneous Regulations: Multiple Net Rule: Nets not specifically authorized for use in this fishery may be onboard the vessel if properly stored. A properly stored net is defined as a net on a drum that is fully covered by a tarp (canvas or plastic) and bound with a minimum of ten revolutions of rope with a diameter of 3/8 (0.375) inches or greater.

Sanctuaries: As applicable: Elokomin-B, Abernathy, Cowlitz, Kalama-B, Lewis-B, Sandy and Washougal River sanctuaries are in effect.

Washington Reporting Rule: WDFW adopted a regulation requiring all Washington wholesale buyers purchasing fish from commercial fisheries to send a report of their landings to WDFW within 24 hours of the closure of the fishery via either:
